➤ Welcome: Branka Marceta, CAERC Director

The meeting started at 1:03 pm. Branka Marceta welcomed members and partners to the meeting. Roll call of members was taken. Fact Sheets: Davis Joint USD Adult Education and El Dorado COE Adult Education

- Grace Sauser presented Davis Joint USD Adult Education fact sheet. Davis Adult Ed had issues with some of their data for their 2019-20 Parent-Child K-12 Success Program and Workforce Preparation Programs. Both of these programs did not report in TE and the data had to be pulled out of ASAP after the numbers were reported in NOVA Program Area report. In the spring of 2020 they had a number of students dropout due to distance learning. When talking about the 12+ hours of attendance for a student to count as an enrollee, these numbers are really not indicative of the number of students they had contact with and served last year. They had quite a few students enroll, go through orientation, and then not come back when classes switched to distance learning. For the high school program, any students that enrolled in February that did not continue did not meet the 12-hour minimum. They had 42 students served in the High School Diploma Program, but only 15 of them counted because of the 12-hour rule.
- Sometimes numbers look really small due to the 12-hour minimum. Their school does not offer 5-day a week 8-hours a day classes. Their ESL classes only meet 4 hours a week and high school diploma students are only required to attend 1 hour per week. For the high school diploma students who did attend at least 12 hours they had tremendous success last year with 80% of them receiving their high school diploma.

- Davis launched their Nursing Assistant Program last year and they are still working on building up enrollment. They had two small cohorts last year and one of them finished after schools were shut down for in-person learning. They found a new instructor to teach this year's cohort and hope to start it within the next couple of weeks.
- Gary Sutherland presented EDCOE's fact sheet. In spite of the modified instructional year due to COVID-19, EDCOE had a productive 2019-20 program year. During 2019-20 they had 177 enrolled students and 75% of those students were between the age of 18 and 39. 77% of enrolled students had 1 or more employment barrier. 60% of enrolled students are/were incarcerated. EDCOE provides educational services to both South Lake Tahoe and Placerville jails as well as probation. Their largest program area is Adult Secondary, K-12 High School Diploma, and GED Equivalency. 25 high school diplomas or equivalencies were earned last year. The main funding source for EDCOE is CAEP funding.
- This fact sheet only shows a partial picture of what EDCOE offers, since they also belong to the Lake Tahoe Adult Education Consortium, where they report their outcomes from the programs on the "east slope".
- EDCOE has a Pearson VUE Testing Center which has been operating for 7 weeks now. Their Adult Education Program is also offering in person testing and instruction with the proper social distancing measures.
- Karen Malkiewicz asked Gary how their jail program is going. They are still very busy at both jail locations and both teachers are running their programs through distance learning. The inmate services officers at both jails have been picking up and delivering the work for the teachers. The teachers are continuing to grade and assign work. One difficulty so far has been assessment.

Reopening Plans

- Natomas was supposed to reopen on November 16, 2020 but was pushed back to December 14, 2020 due to an agreement between Natomas and the NTA. This date could be changed again if things change.
- San Juan is planning on opening January 5, 2021. They will offer on-site classes only in the morning. They will have a combination of fully online students and hybrid students. They also plan on offering new community education classes that will be strictly online.
- Twin Rivers is planning on opening January 19, 2021. They do not have a CSEA MOU in place and they haven't been able to test students. Worst case scenario is that they may reopen on January 19th for just testing and then work on the hybrid classes.
- Davis is planning on opening January 4, 2021 but it may change depending on what happens in the county before then. They will be adding computer lab hours for those who are having trouble accessing technology. They are also looking into implementing face-to-face testing in the next few months.

Share Out After CAEP Summit

• Branka Marceta shared that it seems that up and down the state it is the more rural areas that are able to re-open versus the more densely populated areas. A colleague from Huntington Beach shared that they are reopening next week for in person classes and the district purchased technology to be able to live stream their classes, even for adult education programs.

- Kelly Hunkins gave kudos to Renee Collins and the CAEP TAP staff on the online conference well done. One thing she learned from the keynote speaker is that when the emphasis is on educating women, the impact on society is higher.
- Branka Marceta noted that Valley Vision colleagues are organizing about Fostering Economic Recovery with a Diversified Workforce to take place on December 1, 2020. More information will be sent out to members.
